# **Rules for allotment cultivation 2025**

# General

• You must grow and maintain the entire plot during the whole growing season. NB the growing season starts 1.5. and ends 30.9.

## **Plants**

- You are only allowed to sow and plant **annual useful plants and flowering plants**. Cultivation of the perennial plants is forbidden (for example berry bushes, rhubarb, etc.).
- The plants should be placed in a way so that they don't grow on the paths or spread over the plot border.

## Allotmentplots

- **Marking off the plot** (with planks, fences) **is forbidden.** Paths and the neighboring plots are boundary markers. Self-delimination of the plot is absolutely forbidden.
- The plot is intended **only for growing** you can not place greenhouses, grills, composts or other structures on it.
- It is permitted to place neat, max. 80 cm high toolbox on the plot (1/plot). Note that pathways must remain free, when placing the toolbox.
- After the growing the plot should be tidied up and all things on the plot should be taken away from the area.
- The city may remove the non-compliant structures as well as other things left behind at the end of the growing season at the expense of the farmer, if they are not disposed of within a separately agreed time after receiving a request.
- Alien species growing on the plot must be removed in accordance with alien species control regulations. The farmer is obliged to remove the alien species growing on his plot and around it.

• Farmers take care of cutting the grass around their own plot.

#### Water and soil improvement

- Those who water with watering can (instead of a hose) have priority to the water point.
- Water points are opened in the spring when the danger of frost has passed and correspondingly closed in the autumn before the frost occurs.
- Water points and water is meant **only for the farmers for allotment cultivation use**.
- Farmers are responsible for soil improvement of their own plots.

#### Waste

- Burning waste and making fire in general is absolutely forbidden on the whole allotmentplotarea.
- Recycling of waste:
  - Compostable plant residues in the area marked out with a sign. Plastic and other waste are excluded from this area.
  - Bringing plant residues from outside the growing area is forbidden.
  - Combustibel waste in for the purpose possible waste bin.
  - Other kind of waste that does not have a receiver you must take away from the growing area yourself.

We oversee that the rules are followed and, if necessary, instruct farmers to correct any non-compliances found. Failure to follow the instruct may result in the loss of the right to lease the allotment plot.
